1. General Instructions (Necessary support documents are to be enclosed)

- A. The tender process will be of two bid system-Technical Bid and Financial bid process. The tenderer should submit two separate sealed covers mentioning Technical Bid & Financial Bid. The tenderer which qualifies in Technical Bid only will be eligible to participate in Financial Bid.
- B. The Bid must Contain the Requisite Tender Document Cost of Rs.5000/-(Rupees Five Thousand only) and EMD of Rs.50,000/- as per the advised mode in the technical tender document. - G. The Tender Evaluation Committee will scrutinize and verify the model & Specifications on the same date and will open the Financial Bids of technically qualified bidders.
- H. The decision of the Tender Evaluation Committee shall be final. The committee has right to alter/modify/add/delete any terms and conditions of the tender call notice. The committee also reserves the right to cancel the Tender process at any point of time without mentioning the reasons thereof.

- 1. Copies of GST returns (FY 2025-26 till latest month), Income Tax return (Last three Financial Years) along with copies of PAN and Valid GST registration Certificate shall be submitted along with the technical BID.
- J. EMD: The value of Earnest Money to be deposited by the bidder shall be Rs.50,000/-. EMD should be in the form of Demand Draft / electronically from any Nationalized Bank in favour of the Deputy Director, Similipal South Wildlife Division, Baripada and must be accompanied with the technical bid. For unsuccessful tenderer EMD shall be refunded immediately after Finalization of the bid. EMD shall be forfeited if the L1 bidder fails to accept the order within 5 days from the date of issue of contract order.
- 2. Experience Criteria: The Bidder should have supplied any electronics to any Govt. Department of Odisha Government / Central Government for 2 years before the bid opening date. Copies of relevant contracts to be submitted along with bid in support. (Copy of Purchase Order / Supply Order / GeM Contract shall be submitted by the bidder for technical qualification). Tampering of Purchase Order / Supply Order / GeM Contract by the sellers shall be rejected outrightly without assigning any reason thereof). Legible copy of the Purchase Order / Supply Order / GeM Contract shall be submitted for technical qualification, if not the sellers shall be rejected outrightly without assigning any reason thereof.

3. Security Deposit / BG:

The supplier shall be responsible for any rectification of problems within the warranty period of 01 (one) year. Replacement of any parts within the warranty period shall be on the part of the supplier.

- K. The supplier should provide the service report to the purchaser. After Award of contract to the successful bidder, the supplier shall deposit 3% of the contract value in form of demand draft / FD Pledge in favour of the Deputy Director, Similipal South Wildlife Division, Baripada for Bank Guarantee/Security Deposit within 15 days of Award of contract. After receipt of the Security Deposit only payment shall be made to the supplier. The Security Deposit shall only be returned to the supplier on demand without interest after following all conditions mentioned above.
- 4. Delivery: 15 days from issue of Contract Order. Non-delivery within the date as in the contract order shall attract penal charges as per Govt. Guidelines.
- 5. Undertaking that all the certificates / permissions / documents are valid and current as on date and have not been withdrawn / cancelled by the issuing authority. The Authority have right to ask for original documents if any doubt arises.
- 6. Only those bidders, who participate in the post-bid enquiry physically, shall be accepted for qualifying for the Technical BID if they are found to fulfil all the technical parameters as mentioned in the BID document. All bidders willing to participate in the Technical Bid physically shall have to attend the post-Bid enquiry. During post-bid enquiry meeting the Bidder shall make a PowerPoint Presentation about the equipment they will be quoting. Bidders not attending the post-bid enquiry shall be disqualified in Technical Bid.
- 7. The bidders are requested to submit the details about their product in their letter head, duly signed during submission of technical bid. Basing on their product specification, and other

- 8. Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings should not be bankrupt. Bidder to upload undertaking to this effect with bid.
- L. Scope of supply (Bid price to include all cost components): Supply Installation Testing Commissioning of Goods and Training of operators. Training shall be given at Baripada Headquarter. If the bidder fails to complete the training within 30 days of receipt of the materials at the desired location as decided by the the Deputy Director, Similipal South Wildlife Division, Baripada then an amount of Rs. 50,000/- shall be deducted from the billed amount. An undertaking to the effect shall be given along with the technical bid.
- 9. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.
- 10. Warranty period of the supplied products shall be 01 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods at consignee location. The seller should guarantee the rectification/replacement of goods in case of any break down during the warranty period.
- 11. The successful bidder has to supply all essential accessories required for the successful installation and commissioning of the goods supplied. Besides standard accessories as per normal industry practice, following accessories must be part of supply and cost should be included in bid price.
- 12. Scope of supply includes Transportation, installation & Commissioning at buyer's point, and GST Charges to be included in the bid.
- 13. After the discovery of Price in the financial each Divisional Forest Officer/Deputy Director concern (DFO, Balasore WL, DFO, Keonjhar WL, DFO, Baripada, DFO, Rairangpur, DFO, Karanjia, Deputy Director, Similipal South Wildlife Division & Deputy Director, Similipal North Wildlife Division) will issue separate purchase order from their official letter pad. The L1 bidder shall submit the equipment and the accessories to the Divisional Forest Officer/Deputy Director concern physically by hand only or sealed pack. Tampering of packed in any form, the material shall not be accepted. No other modes shall be accepted for receiving the items. Only after successful operation of the item's payment shall be made by the concerned Divisional Forest Officer/Deputy Director concern.



- 14. Field testing (both day and night) shall be done in presence of the supplier; if the equipment is found functioning in all aspect, then only the product shall be accepted else it would be rejected without assigning any reason thereof. Flying test shall be obligatory on the part of the supplier at the location within the jurisdiction of the Baripada circle as per the decision of the committee.
- 15. The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.
- 1. Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if: i) The Seller fails to comply with any material term of the Contract. ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent. iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly. iv) The Seller becomes bankrupt or goes into liquidation. v) The Seller makes a general assignment for the benefit of creditors.vi) A receiver is appointed for any substantial property owned by the Seller. vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
