2: INTRODUCTION TO THE PROJECT

Similipal Tiger Reserve covering 2750 Sq. Km of forest area located in the centre of Mayurbhanj district. The buffer area of the tiger reserve has several villages and is prone to forest fires every year between February to May. Traditionally the department depends on fire alerts from satellites received from FSI which is transmitted to field personnel at the ground for quick movement of fire control infrastructure. However, the time period between occurrence and alert transmission varies from 2 hrs to 6 hrs. This resulted in the fire extending to wider area and control of fire difficult. There was therefore a requirement of real-time fire detection. In 2023-24 with the funding from government an advanced AI system was set up in




Figure 1 Tower Location of Similipal

Technology and Infrastructure:

The newly implemented system features the

following components:

- a. Tower infrastructure
- b. Cameras
- c. Solar system
- d. Information transmission system
- e. Control room infrastructure.
- f. AI Software

Existing infrastructure:

Tower Infrastructure:

Five towers were established at strategic locations inside Similipal Sanctuary. These towers are having 4 Tonnes weight bearing capacity that can withstand wind speed of up to 250 Km/hr. The towers are of 25 m tall and located on the top of the hills at heights varying from 800m to 1100m. Each tower has 3 lightening arresters each of -0.05 ohms resistance. The location of the towers are (1)Kusumbani (2) Chahala (3)Kulipal (4) Meghasani and (5)Gudgudia as per *Figure-1*. The following are the influencing factors for deciding the location of the tower which also decide the effectiveness of the system:

- A. The towers are located at maximum possible height as possible for the cameras to have a clear view of the farthest distance to maximise the area coverage.
- B. Each tower is located such that there is line of sight between the towers for transmission of information.
- C. The total area covered for fire detection is maximised and the most fire prome area save effectively covered.

D. Accessibility to the spot is also considered.

Camera infrastructure:


Figure 2. RF antenna and camera

Each tower is fixed with high-resolution cameras. Each camera has a visual range of 15-20 kilometres, effectively covering the entire sanctuary. The cameras are high resolution (Pan, Tilt and Zoom) and work Day and Night (24 x7) connected via RF to the Central Command Room. The PTZ cameras are mounted on towers (Figure 2)

Solar System:

The system is solar powered with inverters of 3.5 KVA at site. The solar infrastructure and the tower are protected in a solar powered fence for protection from elephants. (*Annexure 4*)

Information transmission System:

A robust communication systems to transmit Wireless Connectivity between towers and control room via High-Performance Integrated InnerFeed® airMAX® ac Bridge is provided(Figure 3). The communication between towers and the control room is also through internet. Internet is transmitted from Bariapda via the same radiofrequency used by the system. Therefore, there is high reliability in data transmission. (Annexure 5)

Control Room Infrastructure:

The control Room at Field Director office has been established with State of the Art Technology with high end graphic outputs. Storage Devices have been setup to store the data collected by the cameras. (Figure 4).





3: SCOPE OF WORK

The scope of work covers supply, installation of software for AI based active detection of Forest fire, detection of movement of wild animals, detection of poacher movement and for use in other wildlife related management in Similipal Tiger Reserve alongwith 5 years of comprehensive maintenance contract(CMC) of the equipment.

Component-1

Supply & Installation of AI Software, Analytics -

(Detection should be based on AI for forestFire Management, Risk Index, Weather Data; Fire Propagationetc. In addition to that AI based detection of wild animalsto the extent of identifying species and location and distance)

Componenet-2

Comprehensive Maintenance Contract(CMC)-

Comprehensive Maintenance Contractfor the next five years starting from 2025-26 to 2030-31 of all the components (Cameras, Solar Grids, RF Connectivity, Control room, Towers etc.) for making the project fully operational.

4: INSTRUCTIONS TO THE BIDDERS

- a. The Deputy Director, Similipal South Wildlife Division hereinafter called as "Authority" invites sealed proposals from eligible bidders for "Supply, Installation of Software for AI based detection & surveillance on Forest Fire with Real time Alert System with Comprehensive Maintenance Contract (CMC) for 5 Years" in Similipal Tiger Reserve, Mayurbhanj, Odishaas per detailed scope of work in this RFP document.
- b. This invitation to bid is open to all bidders meeting the minimum eligibility criteria as mentioned in this tender Document.
- c. Not more than one bid shall be submitted by one Bidder.
- d. Proposals must be received not later than time, date and venue mentioned in the Fact Sheet. Proposals that are received late will not be considered in this procurement process.
- e. Bidder who has downloaded the tender document from the official website:

 (www.similipal.org) shall not tamper/modify the RFP form including downloaded price bid template in any manner. In case if the same is found to be tampered /modified in any manner, bid will be completely rejected and EMD would be forfeited and Bidder is liable to be banned from doing business with theauthority.
- f. The authority will award the contract to the successful bidder whose proposal has been determined as the best value proposal based on Technical and Financial evaluation criteria and accepted by the Tender Accepting Authority.
- g. The authority reserves the right to reject any or all the Bids in whole or part, prior to signing of the Contract, without assigning any reasons.

4.1 General Instructions

- a. All information supplied by Bidders may be treated as contractually binding on the Bidders, on successful award of the assignment by the "Authority" on the basis of this tender.
- b. No commitment of any kind, contractual or otherwise shall exist unless and until a formal written contract has been executed by or on behalf of the "Authority". Any notification of preferred Bidder status by the "Authority" shall not give rise to any enforceable rights by the Bidder. The "Authority" may cancel this public procurement at any time prior to a formal written contract being executed by or on behalf of the "Authority".
- c. This tender supersedes and replaces any previous public documentation and communications, and Bidders should place no reliance and dependence on such communications.

4.2 Compliant Proposals/ Completeness of Response

- a. Bidders are advised to study all instructions, forms, terms, requirements and other information in the tender documents carefully. Submission of the bid shall be deemed to have been done after careful study and examination of the bid document with full understanding of its implications.
- b. Failure to comply with the requirements of this paragraph may render the Proposal non-compliant and the Proposal may be rejected. Bidders must:
- Include all documentation specified in this tender.
- Follow the format of this tender and respond to each element in the order as set out in this tender.

5: DETAIL TERMS AND CONDITIONS

Detailed Terms and Condition for Tender for "Supply, Installation of Software for AI based detection & surveillance on Forest Fire with Real time Alert System with Comprehensive Maintenance Contract (CMC) for 5 Years" in Similipal Tiger Reserve, Mayurbhanj, Odisha"in various Forest & Wildlife divisions under Baripada Circle, Odisha are as under;

A. Technical Bid

5.1 The AI algorithms shall be designed in such a way that it will detect the forest fireautomatically through the camera feed and gives instant alert to the control room and the users registered mobile number on real time basis.

- 5.2 The software shall provide continuous feed of information on 24x7 basis. In the event of wild animal detection, the AI camera shall be trained to the extent to identify the species, it's exact location with GPS etc.
- 5.3 The software shall have the capacity to detect and distinguish each and every object separately with object attributes from the camera feeds.
- 5.4 The system should carry high degree of accuracy while determining the spatial location of the objects. The accuracy should always be less than or equal to 50 mtr.
- 5.5 The software shall be one time license subscription for the user. No annual recurring cost or hidden charges are allowed.
- 5.6 The software dashboard should be user friendly containing all required information and data base.
- 5.7 The system should have complete flexibility for upgrading and expansion in all respects depending on future requirements. The system should have liberty to add additional module in future based on the requirement.
- 5.8 The Authority reserve the right to accept or deny the proposal for additional modules at any point of time without assigning any reason thereof.
- 5.9 Technical bid should contain technical details provided along with relevant supporting Documents attached such as technical specifications, technical compliance, and data sheets.
- 5.10 The System shall be accepted based on the test certificates submitted by the manufacturer/bidder and successful completion of all the components as an integrated system after Installation & Commissioning at the installation site. Not meeting any of the component specifications will lead to rejection of the system as a whole.

B. Financial Bid

- 5.11 Financial bid(s) of the only technically qualified tenderer(s) will be opened for financial evaluation. Prices should be inclusive of all Taxes & Duties, as applicable. The financial bid(s) will be evaluated on the basis of the total cost as quoted.
- 5.12 Financial bid will be opened day after the technical bidding date i.e. 04.01.2026 at 11.00 A.M onwards in the office of the Deputy Director, Similipal South Wildlife Division, Baripada in presence of the bidder or their representative.

C. General Term & Condition

- 5.13 The bidders who wish to supply the system shall produce the Test/ Qualification Certifications of the cameras. Bidding without certificates or producing fake certificates may lead to disqualify the bidder.
- 5.14 The complete hardware and software support to be extended by the contractor.
- 5.15 Diagnostic checks shall be done by the system periodically for the proper functioning of the Video Cameras.

No queries will be entertained after this allotted time frame. If it is considered necessary to modify the Technical Specifications or any Tender conditions, the same shall be carried out. The modified tender documents will again be uploaded on the website www.similipal.org for the information of all prospective tenderers.

- 5.17 All the pages of the Technical / Financial Bid format shall be page numbered and all the relevant supporting documents as required must be enclosed along with tender.
- Payment Terms: 90% payment of the order value of the software shall be released after satisfactory installation and testing of the software performance. Balance 10% of the order value shall be released after 180 days after satisfactory installation and submission of the test report. No advance payment will be made under any circumstances. For comprehensive Maintenance contract (CMC) the vendor will be paid quarterly in proportion to the contract value for 5 years subject to availability of funds.
- The maintenance work should be carried out in close coordination with the authority, field staffs and with minimum disturbance to the wildlife and its habitat. No works shall be executed after sunset and before sunrise in the sanctuary area. The workers shall strictly abide the provision of the Wildlife Protection Act,1972 or any relevant act time being in force. Any violation of the above provision will be viewed seriously may leads to rescindment of the entire contract.
- be Bidder Firm's responsibility to enforce all 5.20 It measures/precautions required as per relevant codes for carrying out the not work. The authority shall be responsible mishap/injury/impairment caused to the workers.
- Bidder/Firm has to clean all the debris left behind after work at the end of days. They shall be responsible for labour engaged for their code of
- 5.22 The bid offer should be valid till 180 days from the date of opening of financial bid.
- 5.23 **Termination for Default:** The 'Authority' may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Bidder, terminate the Contract in whole or in part: If the Bidder fails to deliver any or all of the Goods within the period(s) specified in the Contract, or within any extension thereof granted by the Purchaser; or If the Bidder fails to perform any other obligation(s) under the Contract. If the Bidder, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract. For the purpose of this clause: "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a

public official in the procurement process or in contract execution. "fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution or a contract to the detriment of the borrower and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the borrower of the benefits of free and open competition. - 5.24 Force Majeure: In no event shall either Party have any liability for failure to comply with this Agreement, if such failure results directly from the occurrence of any contingency beyond the reasonable control of the Party, including, without limitation, strike or other labour disturbance, riot, major power failure, war, natural calamities including but not limited to floods, earthquakes, fire, volcanic eruptions, epidemics, Emergency, interference by any government or governmental agency, embargo, seizure, or enactment or abolition of any law, statute, ordinance, rule, or regulation (each a " Force Majeure Event"). In the event that either Party is unable to perform any of its obligations under this Agreement because of a Force Majeure Event, the Party who has been so affected shall as soon as may be, after coming to know of the Force Majeure Event, inform the other Party and shall take reasonable steps to resume performance as soon as may be after the cessation of the Force Majeure Event. If the period of non-performance due to a Force Majeure Event exceeds thirty (30) days, the Party whose ability to perform has been so affected may, by giving written notice, terminate this Agreement.
- 5.25 The incomplete and conditional tenders will be rejected. Quoting of unrealistic rates will also be treated as disqualification.
- 5.26 Bidder shall not be permitted to withdraw his/her offer or modify the terms and conditions thereof after acceptance of tender. In case the Bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rate, the aforesaid amount of Earnest Money Deposit and Performance Guarantee will be forfeited by the 'Authority'. Besides this, the Bidder will also be liable to be debarred/blacklisted from participating in the tendering process of the 'Authority' in future and/or suitable penalty will be levied.
- 5.27 Normally no extensions of the scheduled delivery or completion dates should be granted except where events constituting force majeure, as provided in the contract, have occurred or the other circumstances demands for.

- 5.28 All the applicable taxes are to be paid by the Bidder/Firm. Price should be quoted accordingly. No price variation shall be allowed during the contract.
- 5.29 On receipt of intimation from the 'Authority' of the acceptance of his/their Tender, the successful Tenderer shall be bound to implement the contract and within 7 days thereof, the successful Tenderer shall sign an agreement and the Schedule of terms and conditions but the written acceptance by the 'Authority' of a tender will constitute a binding contract between the 'Authority' and the person so Tendering whether such formal agreement is or not subsequently executed.
- 5.30 Minimum oneweek Training Programme needs to be scheduled/arranged by the successful bidder, without any additional extra charges. The supplier shall provide training at desired places as fixed by the authority for personnel of user department on the operation, maintenance of the software. Training manuals [5 copies] towards this should be prepared and handed over to the user department before starting of the training.

5.31 Arbitration

- a. In the event of failure to carry out the contractual obligations, with in the stipulated period or extended period and determination of the contract for any reason. Violation of the warranties etc. the 'Authority' shall have the right to carry out the unfinished obligation at the exclusive cost and risk of the bidder/firm, after due notice and the difference so accrued shall be recoverable from the bidder/firm.
- b. The provision of the Arbitration and conciliation Act, 1996 or as at relevant time and of rules framed there under and any statutory modifications thereof shall be deemed to apply and be incorporated in this agreement.
- c. Upon every or any such reference, the cost of any incidentals to the reference and award(s) respectively shall be at the reasonable discretion of the Arbitrators or in the event of their not agreeing, of the Umpire appointed the amount thereof or direct the same to be fixed as between solicitors and client or as between parties and shall be direct by whom and in what manner the same shall be borne and paid.
- d. Panel of arbitrators will be provided by the 'Authority' out of which the bidder will have to select one.
- e. The bidder shall have no objection if the officer who has dealt with the case at any stage is nominated as an arbitrator. Further, that one of the arbitrator's shall be Accounts Expert.
- f. In case of vacancy being caused due to resignation, death or incapacity of the arbitrator's to function as such, the same shall be provided in the aforesaid manner and the new arbitrator's shall proceed from the stage at which vacancy is caused.



g. All disputes shall be subject to the jurisdiction of the Court of Law at Baripada, Mayurbhanj, Odisha

6: KEY REQUIREMENTS OF THE BID

3. Bidder Eligibility:



Any false and/or inadequate information can result in rejection of the tender.
